Rule 1: New Car Each Year

For each year a NEW car must be built using the four wheels and axles provided in an Awana Grand Prix kit. A piece of the original block of wood must be used.

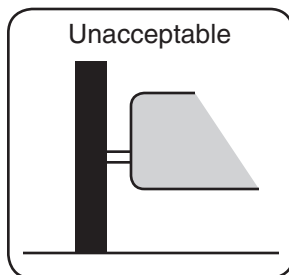
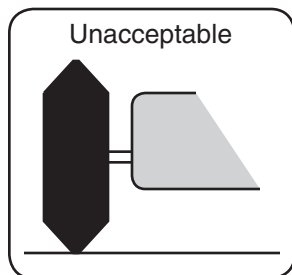
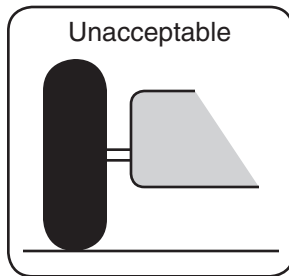
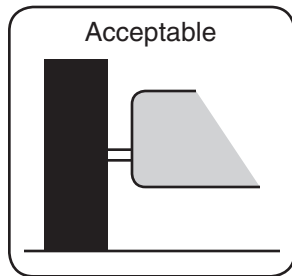
Rule 2: Ground Clearance

Your car should have 3/8" or greater ground clearance. This ensures your car does not rub against the lane's center strip. Any less than 3/8" you race at your risk.

Rule 3: Wheels

- **All cars — clubbers and leaders —** with modified or shaped wheels will be disqualified. The wheels may be gently sanded to remove surface imperfections, as long as the wheel surface remains flat. Wheels must be full width, as provided in the kit. Wheels can not be tapered or reformed to reduce their "footprint" on the track.

The wheel surface may be changed (i.e. to remove surface imperfections) as long as the surface remains flat.



- "Awana Grand Prix" must be able to be read on the side of the wheels.
- Only official Awana axles may be used.
- Axles may be sanded and polished.
- Wheel bearing, bushings, washers, and springs are prohibited. The wheel must only come into contact with wood or paint.
- A lubricant of your choice may be used. Note: No lubrication will be allowed after your car has been placed on the pit table.

Rule 4: Car Dimensions

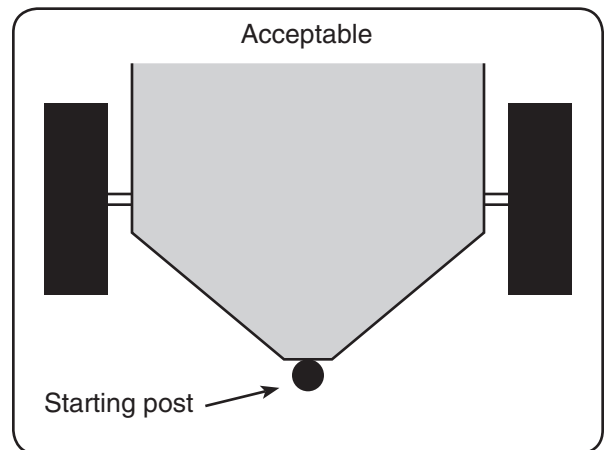
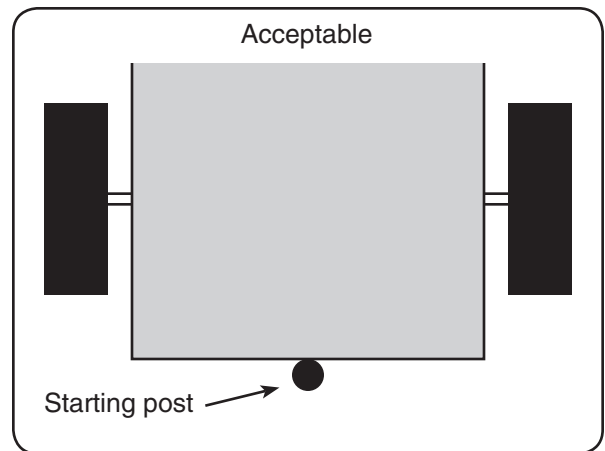
- Maximum car length — 7"
- Maximum car width — 2-3/4"
- Ground clearance — 3/8"
- No height requirement

Rule 5: The Car Weight must NOT exceed 5 ounces.

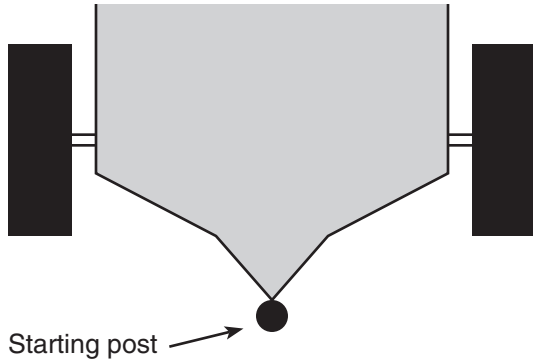
- Weights must be secured to the car body, and must not violate the dimension rules or 3/8" clearance.

Rule 6: The Car's Leading Edge

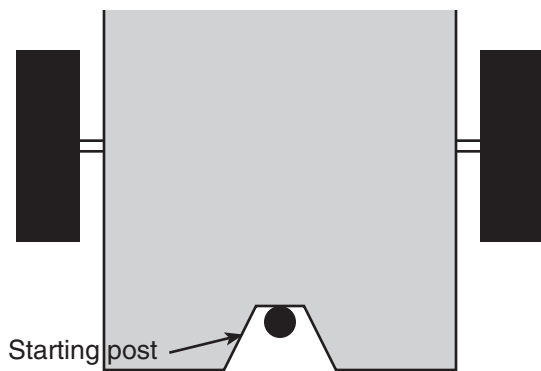
- Designs where the leading edge wraps around the starting post are not permitted.



Not recommended — race at your own risk.



Not acceptable



Rule 7: Competition

- Each clubber will have the opportunity to race his or her car at least twice.
- You can only register and race your own car.
- Car must meet racing specifications in order to be considered for design competition.
- A car may not have had been raced in any other regional Grand Prix. Must be a current year car.

Rule 8: Miscellaneous Rules

- Starting devices are prohibited. Car must be free-wheeling.
- A part of the original block of wood must be used.
- Model kits are not permitted.

Rule 9: Inspection

- A car must pass inspection by the Awana Grand Prix inspector(s) in categories of weight, length, width, height, and other specifics. Inspectors may send cars to the repair station if there is any question about meeting these standards.
- Once a car has passed inspection and has been placed on the pit table no more tinkering, repairs, or lubrication is allowed.

Rule 10: Repairs and Test Runs

- A pit area will be available for general repairs. After 11:30 AM repairs will be limited to removing excess weight.
- In case of an accident, only those repairs that can be done by hand while going between the end of the race track and pit table are allowed.
- **Test runs** will only be allowed for racers who arrive early. There will be no racing during trial runs. Trial runs may be cut off at 11:30 AM.

Awards:

Racing: First, Second, and Third place trophies

Design: First, Second, and Third place trophies

Participation Ribbon: to all participants

Commander's Cup: A traveling trophy that is awarded to the church that does the best overall. A minimum of 5 racers (clubbers only) is required.

Additional Design Awards

There are First and Second Place trophies for each design category.

Most Authentic — the car that looks most like a street car (i.e. the one that best resembles a particular make or model)

Most Colorful — the brightest-flashiest car

Most Creative — the most unusual looking creation

Spirit of Awana — The car that best exemplifies the Awana Spirit

Registration:

- Each church needs to register.
- Each individual racer needs to be listed by category on the registration form.
- A racer is pre-registered if his name has been submitted by the Saturday before the Grand Prix.
- Please list anybody and everybody who might attend. They do not have to pay if they do not show.
- A late or at-door registration is a person who has missed the registration deadline.
- All individual racing fees — both pre-registered or at-door are to be paid on the day of the event.
